How do I sign up?

Complete this form and return to your payroll co-ordinator.

Can I change my commitment or cancel at any time?

Absolutely! Just inform your Payroll co-ordinator of your changes/cancellation.

How do I benefit from pre-tax giving?

The tax calculated each pay will be done after your donation has been deducted. This means you pay less tax each pay. By receiving the tax benefit up front you won't need to wait until the end of the financial year. It make handling your cash flow easier as well.

What is Work Place Giving?

Employee Work Place Giving donations are given through payroll in a pre-tax manner. You receive an instant tax refund with no need to keep receipts or wait until making your annual tax return claim.

How do my Work Place Giving donations help families with sick or injured children?

Your Work Place Giving donation can provide:

- A 'home away from home' at Ronald McDonald House for families travelling over 25kms to Orange to receive hospital care for their sick or injured child.
- Support for families at the bedside of their sick or injured child in the Dubbo Base Hospital.
